

## **Jena Prescott, MPSA**

### **Associate Transportation Researcher**

Jena Prescott has over five years of experience as an impaired driving researcher. Mrs. Prescott received her Bachelor of Arts in Political Science from Texas A&M University in 2007. She received her Master of Public Service and Administration, with an emphasis in Public Policy Analysis from the George Bush School of Government and Public Service at Texas A&M University in 2013. During her time as an impaired driving researcher, she has been involved in numerous projects evaluating impaired driving countermeasures and their effectiveness, as well as developed curriculum to educate law enforcement, prosecutors, members of the judiciary and probation officers. Mrs. Prescott has also served as the principle investigator on projects evaluating ignition interlock devices, improving blood alcohol concentration reporting in fatally injured drivers in Texas as well as evaluating marijuana's impacts on traffic safety. Her research interest areas include alcohol and drug impaired driving, impaired driving policy as well as the impact of alcohol and drug impaired driving on traffic safety.
