HISTORY

Marijuana Tax Act of 1937

This act stopped the use of the plant as a recreational drug.

Boggs Act 1951

The Boggs Act in 1951 set mandatory sentences for drug convictions.

Controlled Substances Act 1970

This act categorized drugs on medical usefulness and potential for abuse. Cannabis was listed as a Schedule 1 drug (most restrictive) with heroine and LSD.

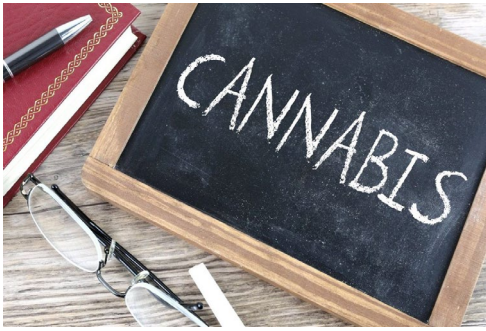


California Passes First Medical Marijuana Laws - 1996

Other states began establishing laws permitting marijuana for medical use.

As of May 2023

23 states allow recreational use, and 17 states allow medical use for qualifying individuals.

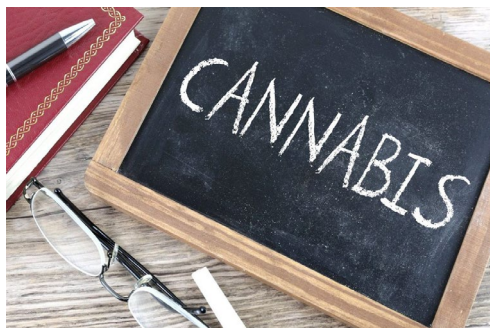

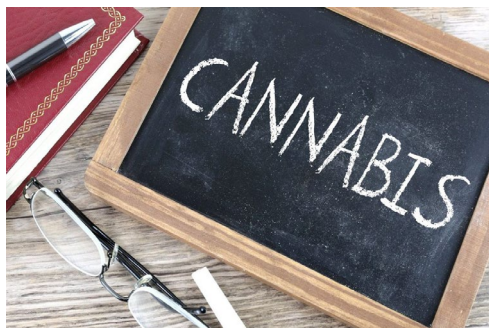

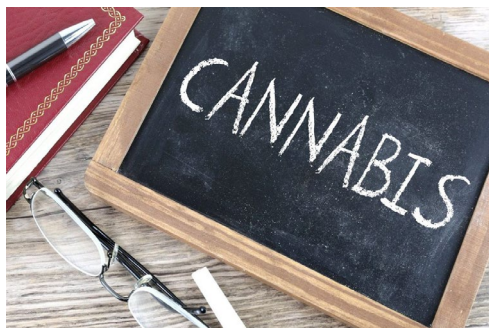

Prepared in accordance with Section 4008 (Marijuana-Impaired Driving) of the Fixing America's Surface Transportation Act, this report acknowledges what is both known and unknown regarding marijuana impairment and driving, as well as covers some of the challenges of measuring impairment levels in drivers. State laws and crash risks are discussed, and feasibility with regard to training law enforcement to detect marijuana impairment are addressed.

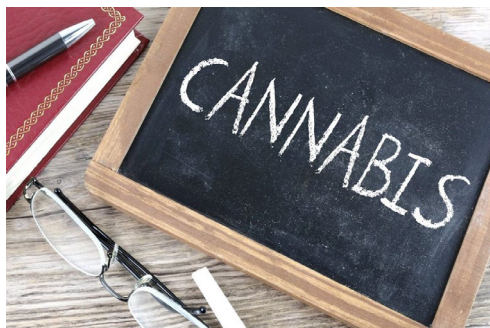

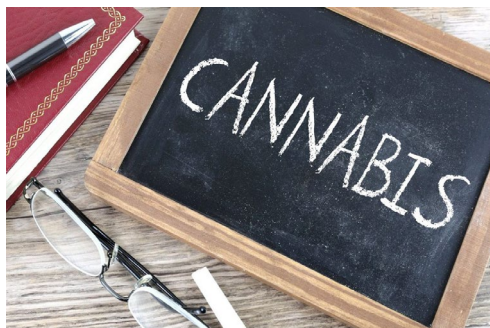
This bill passed I the 86th Texas Legislature in 2019 and allows for the cultivation of the Cannabis sativa L. plant with THC content less than 0.3%.

A person commits an offense if the person is intoxicated while operating a motor vehicle in a public place, and there is no defense for medical use.

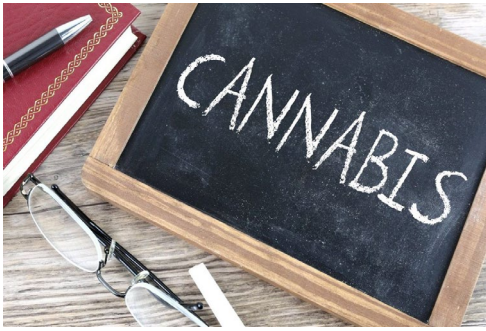
Texas Transportation Code Sec. 724.011 Consent to Taking of Specimen
